HB&G Building Products Inc. warrants to the purchasers of our products to be free from defects in craftsmanship and materials as spelled out below:

Our Limited Product Warranty Terms:

- Warranties are exclusive to the person(s) who own and reside in the home the product is installed
- Warranties also apply to the Homeowner who purchases a newly constructed residence on which the Product is installed directly from the builder
- Warranties are not transferable
- These Warranties are only applicable in the United States and Canada

Our Warranties cover:

- Our products, when used under the conditions of normal use and are properly installed and maintained in conformance with all of HB&G installation instructions (see QR Code below) as well as all governing building codes
- HB&G factory-finished products (Pergolas, PermaPost® and Railing) will be free of defects (will not peel, chip or crack) for a period of one year in normal use and are properly installed and maintained in conformance with HB&G installation instructions. This includes Normal weathering such as exposure to sunlight which may cause any finished surface to gradually fade, chalk or accumulate dirt, and/or other Acts of God

Limitations and conditions not covered:

- Non factory-applied finishes are not covered under this warranty. For claims original purchasers must look to the warranty of the paint or coating manufacturer for recourse
- Defects in the foundation, wall or ceiling structure on which HB&G products are installed, which cause failure
- Installation, delivery and labor costs are NOT covered under this warranty
- HB&G does not warrant split columns sold direct or by distributors, builders, retailers, suppliers or anyone

- If HB&G determines, at its sole discretion, that a product has a manufacturing defect, the repair or replacement of those materials will be the sole remedies
